The journey was made in a heavy two horse wagon, taking fifteen days; when they reached the Canisteo River, at a place called Sanders, there they took off half the load and with a man at each wheel with a hank-spike to hold the wheels so the horses could take a rest every few minutes, and the mother walking and carrying the child Alfred, they started up the hill. After going about six miles over terrible rough and muddy roads, they arrived at the door of the only house on the hill, where lived a Mr. Finch. The house was of logs, the floor was of split logs, but there was a glowing fire in the hearth, and warmed the hearts and loving hands to minister to the needs of the now fainting mother. Here, they remained until they could put up a house for themselves. The next year, Thomas Allen, wife and two children, Elexander Campbell, wife and four children, John Hull, wife and two children, also two hired men, came from New Jersey, and in Mr. Northrup's house of two rooms, they all lived for more than three weeks, while they built for themselves homes in the wilderness. It was twenty miles to the nearest flouring mills, and the forests abounded in deer, bear, wolves, wild cats and rattlesnakes. The children of to-day can scarcely realize what privations and hardships THEIR ancestors had to endure in order to leave their homes of comfort and even luxury. Joseph Northrup remained for ten years, then returned to New Jersey, where he died thirty-two years later, after accumulating a handsome property. He sold his farm in Rathbone to his brother Benjamin, of New Jersey. Alfred was ten years old when he returned to New Jersey with his father, but when twenty six years old, returned to Rathbone and settled on the farm now owned b his widow, consisting of 212 acres. Here, Mr. (Alfred) Northrup died September 28, 1891. December 12, 1852, he married Lucy J. Cutting, daughter of Zachariah and Anna (Wadsworth) Cutting, natives of Onondaga County, New York. Mr Cutting came to Cameron in 1846, where he died. His wife died in 1877.

Scituate to be equally divided; to "the said Thomas my son one-third part of all my lands at Seconet which is purchased, & the other two-thirds I give unto my two sons Benjamin & Isaak Woodward" to be equally divided, "excepting twenty & five acres which I do give unto my son Joseph ... & ten acres the which I do give unto my daughter Martha"; "all the rest of my land at Seconet which is yet to be purchased I give unto my two sons Thomas & Joseph Woodward" to be equally divided; to "Benjamin my son aforesaid my dwelling house with my barn & other outhousing with all my land both upland and marshland thereunto belonging, that is to say twenty acres of upland ... & six acres of marshland ... upon condition that my son Benjamin aforesaid do pay & allow the sum of seventy pounds unto my son Joseph & my six daughters Sarah, Elyzabeth, Mary, Martha, Mehetabel & Abigaile," £10 apiece, and permit "my two daughters Mehetable & Abigaile" to live in the house as long as they are unmarried; to "my said two daughters Mehetable & Abigaile my feather bed with the furniture thereunto belonging & all the rest of my household goods I give unto my six daughters Sarah, Elyzabeth, Mary, Martha, Mehetable & Abigaile" to be divided equally; residue of estate to "all my children"; "my son Beniamine" to be sole executor and "my two sons Thomas & Joseph" to be overseers. The inventory of the estate of Walter Woodworth was taken 25 February 1685/6 and totalled £355 10s., of which £310 was real estate: "one dwelling house & barn & upland & meadow land adjoining thereto with common privileges," £140; "ten acres of salt meadow land," £50; "five acres of upland," £20; and "one whole share of land at Saconet," £100.

In addition, Benjamin's wife is given as Deborah \_\_\_\_\_, with no surname attached.

Records indicate Walter as having "come as a servant" to Plymouth Colony Plymouth Court Records of 02 January 1633/34 order "that whereas by indenture many are bound to give their servants land at the expiration of their terms, it is ordered that they have it at Scituate or some other convenient place, where it may be useful".

Walter first appears in the records on a list of taxpayers in Plymouth Colony, made between 0 January 1633/34 when the tax "for publik use" was ordered, and 27 March, 1634, when the list was presented to the Court. Walter's name falls near the end of the list, and h is taxed at nine shillings. It is assumed he was still a single man, without a house or property, but now not a servant.

In 1634, Walter acquired the first of his considerable land holdings, a house lot in Scituate which was the third lot on Kent Street, with an ocean frontage, at the corner of Meeting House Lane (this tract was subdivided into 5 house lots 8 rods (132 feet) along Kent Street and extended "80 rods up into the woods"); a tract on the First Herring Brook, which was not far below Stockbride Mill, where later tood the boyhood home of Samuel Woodworth (the poet); and another tract on the northeast side of Walnut Tree Hill, just west of the present Queensbush or South Scituate Railroad Station, which in early times was called Walter Woodworth's Hill.

"Walter Woodworth is said to have come to New England from Kent, England, with Governor Winthrop in 1630. The name of the family he founded in N.E. was at first Woodward, but in passing from Mass. to R.I., it became Woodworth. He was a resident of Scituate, Mass., in 1633, where he settled on the third lot in Kent Street, south of Meeting House Land, in 1635, where the men of Kent county, England, settled. He was freeman, March 2, 1641, and Surveyor of Highways in 1645, 46, and 1656. In October, 1664, the Court granted to John Hanmore and Walter Woodward of Scituate, each 60 acres of land, near to Weymouth, provided it entrench not upon former grants, and also that they pay the Indians purchase for it, if any be justly demanded. He [living in 1681] left no will or record as to whom he married, but in the town records of Scituate, a list of his children were found". end of quote. To my knowledge, Walter's origins in England are still unknown, with Kent and Lancashire being the leading theories. Walter's gravesite is also not known, but he did leave a will.

"The name of Woodworth is an American corruption of the English surname of Woodward, meaning 'Warden of the Woods'. It is found in ancient English and early American records in the various forms of Woodward, Wodewarde, Wodeward, Woodwart, Woodward, Woodwort, Woddeword, Woodeword, Woodeworth, Woodworthe, Woodworth, and others, of which the last mentioned spelling is more frequently used in America today. It is generally believed that the Woodworth family in America are descendants of the Woodward family of County Kent. (R)11

The Coat of Arms of the family of Woodward of County Kent, England, is generally described as follows:

Arms "Argent, a chevron sable, between three grasshoppers vert."

Crest "A demi woman (another account gives a demi woodman) couped at the knees, vested gules, hair dishevelled or, in the dexter hand a honeysuckle of the first, stalked and leaved, vert." (R)12

G Alan Royce, a Woodworth family historian, has also researched how the Woodward clan came to England:

"From an old deed of estate conveyance found in the archives of the Island Church of Barfleur, Normandy, in 1840 by John Manion, a distinguished notary

of Cherbourg, Normandy, we learn that a family of noted 'Sea Kings of Elsinore', Norway, 912 AD, named 'Vidarvorde', equipped 10 ships for the service of Rollo, first Duke of Normandy. For that gallant service to said prince on the Norman coast, 'Rurick Vidarvorde', head of said family was granted the Demense of Chau, de la Montague, Val de Saar, Normandy, where the family lived in opulence and high respect up to the Norman invasion of England.

....the name of this ancient Anglo Norman family up to the year 1066 was spelled De Boisgarde, having been translated from the Norse spelling to Norman French....For 'Valorous service at the Battle of Hastings', two gentleman at arms, Guilliame and Richard de Boisguard were chartered under royal seal of William the Conqueror, to manors at Shoevington and Standish, County of Lancaster. In the deed of conveyance they had their name Du Boisgarde, Anglicized to Woodward, such being a literal translation. They had the honor of having their names enrolled among those 648 knights whose names were preserved in the tapestry hung by William the Conqueror in Battle Abbey..."(R)9

"....Vedvord (Vid Varde)(Wards of the woods) under the first Duke Rollo, fitted out ten ships at his own expense to be used in the conquest of Bretange, now part of France. Here the name was changed in due course to De Boisguard. From France, they migrated to England, where the name was Anglicized to 'Woodward'. Father Walter, and probably his brother Thomas, came first to America in 1628 and returned to England after a short stay. Walter returned with his family in the ship, 'Mary and John' ca 1630. Walter Woodward, b. Kent, England, married and had children."

According to the theory advanced by family geneologist Maurice Woodworth, Walter Woodworth, was born in England, most probably in Lancashire, between 1610 and 1614. Relatively nothing is known about his wife or parents. He came not from London as did the Men from Kent, as some geneologists have stated in early records, but from Plymouth, England. (R)184

It is believed that he sailed on the ship "Mary & John", a ship of 400 tons, sailing from Plymouth on March 20, 1630 under the command of Capt. Squeb. She was one of eleven ships comprising Governor Winthrop's fleet and was bringing supplies to the Puritans. He arrived at Nantucket Point on the Massachusetts coast, where all the passengers were put ashore on the nearby beach to fend for themselves on May 30, 1630. (R)185

Though it is known that there were 140 passengers on this voyage, six names are missing from the parchment, including Walter under "W" and those listed under "Y" and "Z".(R)1

Walter, yet a young man, made his way to the Plymouth Colony, and we soon

find him settled at Scituate among the "Men from Kent". There appears no evidence that he was yet married. He was a planter and surveyor of highways and settled many of the local disputes and helped establish boundary lines. He helped layout the town of Scituate, and records show that he paid taxes in 1633. According to "History of Scituate" by S. Deane, 1831, p.9, Walter purchased the third lot on Kent Street; the first assignment being 12 April 1633 and the second being 20 Feb 1634. (R)4

Another source tells us that Dean's book states that on Aug. 2, 1633, the settlers proceeded to lay out a regular village where Walter already had a house. The records show that Walter had lot 3 which was on the south side of Meeting House Lane. George Lewis had lot 1 and John Hewes had lot 2. In 1635 Walter was assigned lot 8 on Kent St, which runs along the ocean front, and there he built himself a house. He also owned other lands in 1635, among which was a tract of land below Stockbridge Mill, whereafter stood the home of the poet who wrote "The Old Oaken Bucket", Samuel Woodworth. The hill west of the railway (Walnut Tree Hill) also belonged to Walter and was then called Walter Woodworth's Hill. (R)185

In 1654 he was a member of the First Church. In 1666, he also bought 60 acres in Weymouth. (R)210

He was propounded as a freeman on Dec 1, 1640, and admitted March 2, 1640. He did not appear to be educated as he signed his will by mark. He was listed in the Scituate section of the 1643 Plymouth list of men able to bear arms. He is on the June 3, 1662 list of servants and ancient freemen granted land, and as a consequence on Oct. 4, 1664 was granted sixty acres. (R)122

Frank E. Woodward , of Malden MA, unearthed the last will of Walter Woodward, of Scituate, coming upon it quite by accident among the records in Plymouth County, MA. (R)10 The following is from a typed copy of the will which has the N.E. Historic Genealogical Society stamp on it:

"In the name of God, Amen I, Walter Woodward, of Scituate, in the jurisdiction of New Plymouth in New England, in America, being weak in body, but of sound and perfect memory, praise to Almighty God for the same, do make this my last will and testament in manner as followeth:

First, and most principally, I commend my soul into the hands of Almighty God my creator, in and through Jesus Christ, my only Saviour and Redeemer, and my body unto decent and ---burial at the discretion of my executors with the advice of the rest of my sons hereafter named.

And my temporal estate I dispose of as hereafter followeth:

Imprimis. I give and bequeath unto Thomas Woodward, my eldest son, a parcel

of upland containing--- acres, lying in Scituate aforesaid, bounded by the lands of Henry Ewell on the south and the Common on the north, to be enjoyed to him and his heirs forever.

Item: I give unto my two sons, Thomas and Joseph, ---acres of Marsh land, to be equally divided between them, which lyeth by Suzons - bounded by the Marsh of Anthony Collimer on the east, by the Marsh of Thomas Clap, deceased, on the north, in Scituate aforesaid to be enjoyed to them and their heirs forever.

Item: I give to Thomas Woodward, my son, one-third part of all my land at Seconet, which I purchased. The other two-thirds I give unto my two sons, Benjamin and Isaac Woodward, to be equally divided between them, to be enjoyed to them and their heirs forever, excepting twenty-five acres, of which I do give unto my son Joseph, to be enjoyed to him and his heirs forever. Ten acres of which I do give unto my daughter, Martha, to her, her heirs forever, of which two quantities of land is to be deducted out of the two-thirds of my land lying at Seconet given to my two sons, Benjamin and Isaac aforesaid. All the rest of my land at seconet, which is yet to be purchased, I give unto my two sons, Thomas and Joseph Woodward, to be divided equally between them, to be enjoyed to them and their heirs forever.

Item: I give to Benjamin, my son aforesaid, my dwelling-house with my bards and other outhousing, with all my land, both upland and marshland thereunto belonging, that is to say, twenty acres of upland, be it more or less, bounded by land of John Turner to the west and by land of Joseph Otis to the east and six acres of marshland more or less bounded by the land of Joseph Otis to the northeast, and by the first herring brook towards the south-- all of which said housings and land with all the appurtenances thereof, the commons and priviledges threunto belonging I give to the said Benjamin, my son, his heirs forever, always provided upon condition that my son, Benjamin, aforesaid, do pay and allow the sum of seventy pounds unto my son, Joseph, and my six daughters, Sarah, Elizabeth, Mary, Martha, Mehitabel and Abigail, ten pounds apiece to be paid to them at three payments, viz, one-third part of the said seventy pounds to be paid to my said children within three years after my decease and the other two-thirds to be paid in the two following years, that is to say-- in each year a third of the said sum of seventy pounds, and each payment to be paid, the one-half in silver and the other half to be paid in corn; and (cattell?). Further, my will is that my son Benjamin, aforesaid, do allow my two daughters, Mehitabel and Abigail, the lower room or parlor at the northeasterly end of my dwelling house aforesaid, for their use during the time they do live unmarried.

Item: I give and bequeath unto my said two daughters, Mehitabel and Abigail, my feather bed with the furniture thereunto belonging and all the rest of my household goods I give unto my six daughters, Sarah, Elizabeth, Mary, Martha,

Mehitabel, and Abigail, to be divided equally among them. The rest of my estate undisposed of by this my last will and testament, I give and bequeath to all my children, all my debts, funeral expenses being first paid, to be equally divided amongst them.

Item: I do constitute and appoint my son, Benjamin, aforesaid, the sole executor of this my last will and testament, whom I do appoint to pay all my debts and legacies and I do appoint my two sons, Thomas and Joseph Woodward, overseers of this last will and testament.

In witness whereof, I have hereunto set my hand and seal the twenty six day of November, 1685.

The children of Walter Woodward in America all began to use the family name of Woodworth. (R)184

Family lore has it that Walter was a strong supporter of the Puritan pastor, the Reverend Charles Chauncey, who became the second president of Harvard College. Walter proposed to turn over his house to the minister as a gift if he would stay in Scituate. Rev. Chauncey was at that time in the center of a religious controversy and those of the family that disagreed with him withdrew and changed the spelling of the name to Woodworth. This spelling is not found on documents until 1645. Walter signed his will Woodward but the oath of his son and executor Benjamin was signed Woodworth on March 2, 1686. (R)185

The name of Walter's wife does not appear in his will or any town records of

the time, but in the "Witchcraft Play", her name is given as Dorothy. She was living in 1676. (R)185

There is also a plausible theory that Walter's wife was Elizabeth Rogers, the daughter of Thomas Rogers of the Mayflower. When the Pilgrims sailed from Leiden in the Netherlands, Thomas Roger's wife and 2 daughters remained behind. Thomas sailed with his two sons, Joseph and John. No one knows for sure what became of Elizabeth and Margaret, his daughters, after the death of their mother in Leiden. It is likely, however, that they sailed for New England to join their brothers, and that they married after arriving here. Elizabeth would therefore have been the right age and in the right place to have been married to Walter, as is apparently the claim of Jeanette Behan, but I do not know if there is any proof to substantiate the theory.

Of the four sons of Walter Woodworth, his eldest son Thomas has the least amount of descendants on record in the typescript with less than 30 pages, total. Benjamin, Walter's third son has the largest number of descendants and they take up in the neighborhood of one half the pages in the approximately 1000 page typescript; Joseph, Walter's second son, would place second next to Benjamin; Isaac, Walter's youngest son, would fit in between Thomas and Joseph. Thomas and Joseph are the two sons whose lines need the most work on them, although all lines are incomplete in one way or another. (R)184

There is some argument that there was also a son named Walter. In "The Great Migration Begins: Immigrants to New England, 1620-1633", by Robert Charles Anderson we find "Savage, 4:648, following Deane, says that the immigrant had a son Walter who had children Mary, b. 1658, Mehitable, 1662, and Ebenezer, 1664. There is only evidence of one Walter Woodworth in early New England, as no record refers to Walter Sr. or Jr. The immigrant had daughters named Mary and Mehitable, and no record for an Ebenezer is seen.

In arranging the children of Walter Woodworth, the assumption has been made that in his will he named his sons in birth order and his daughters in birth order. This permits a births sequence for the children which is consistent with other known dates.

On 7 July 1681 "Walter Woodworth of Scituate" sued Japhett Turner for tearing down some of his fencing, and was awarded "five shillings damage and the cost of the suit"; the "Bill of Cost," apparently prepared by Woodworth himself, totalled £3 16s..
